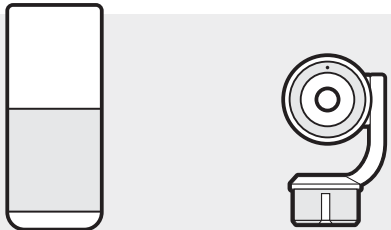

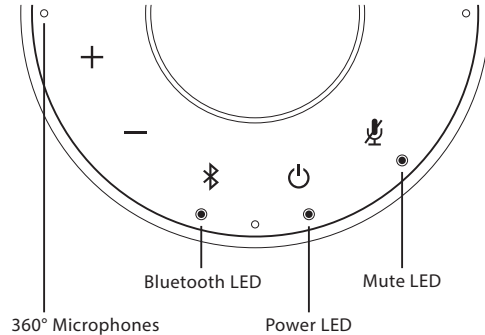

### Getting to know your Video Conference System HD SC100

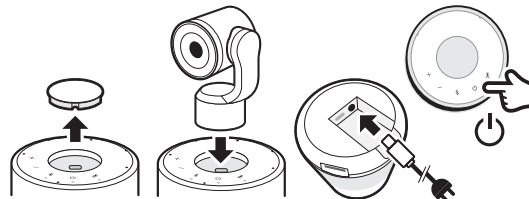


- + Volume up**  
Tap to increase volume
- Volume down**  
Tap to reduce volume
- Bluetooth**  
  - Connect with new Bluetooth device**  
Press and hold to enter Bluetooth pairing mode to connect with a new Bluetooth device
  - Disconnect or reconnect with Bluetooth device**  
Tap to disconnect or reconnect with a paired Bluetooth device

Press and hold to turn S100A on/off
- Mute**  
  - Mute microphone**  
Tap to mute or unmute microphone
  - Voice guidance**  
Press and hold 10s to turn voice guidance on/off

### Getting Started

#### 1 Turn on the SC100

- Remove the top cover of S100A conference speaker and snap in C100 conference camera module.
- Plug the included power adapter into a power outlet and connect the other end to S100A
- Press and hold [ ⏻ ] on the top of the speaker for 2 seconds to turn S100A on and 3 seconds to turn it off.



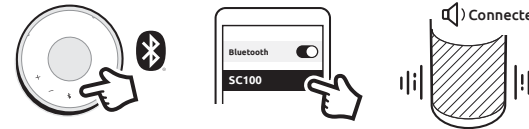
#### 2 Connect SC100 to your computer

- Plug the included USB cable into your computer and connect the end with the type-C connector to the SC100.
- Select SC100 as the default microphone and speaker source. Select SC100 as the default camera source.



#### 3 Connect SC100 with a Bluetooth Device (Audio Only)

- Press and hold [ ✳ ] for 3 seconds until the Bluetooth LED on SC100 begins flashing. You will hear connection guidance voice prompts.
- Enable Bluetooth on your Bluetooth device.
- Select SC100 from the list of available Bluetooth devices to connect.
- You will hear the SC100 say "Connected".
- Tap [ ✳ ] to disconnect with connecting Bluetooth device.

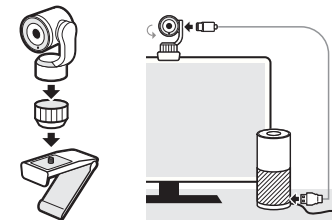


#### 4 Mute/Unmute

- Tap [ ⏻ ] while calling to mute or unmute the microphone.

#### Mount C100 on Display

- Snap C100 into tripod adapter and attach it to the included display mount.
- Mount C100 on top of the display and adjust the camera view to correct position.
- Plug the included USB cable into either USB port at the bottom of S100A and connect the other end with the type-C connector to C100
- Select S100A and C100 as the default audio and video source on your computer
